Lenz Inc. Compliance with REACH Statement

REACH (Registration, Evaluation, Authorization, and Restriction of Chemicals) is a European Union Commission (EUC) regulation on chemicals and their safe use (EC 1907/2006) entered into force June 2007 and will be phased in until 2018.

Lenz supports the basic aim of REACH in improving the protection of human health and environment through better and earlier identification on intrinsic properties of chemical substances in its products as required.

Under REACH, registrations of substances which are used in the manufacturing of articles do not apply to Lenz operations.

As per EC1907/2006 Lenz is the producer of the "articles". These articles are objects that have a specific shape, surface or design and do not have intended releases of substances during their normal use or under foreseeable conditions of use. These products may (1) contain small quantities of substances such as oils, lubricants from production, (2) release substances during their normal and intended use as an unavoidable side-effect of the functioning of the article, (3) have a release during the maintenance of the article meant to improve the product quality or safety or, (4) have a release due to an intended use, use beyond normal limits accident or failure. All of these examples of releases are unintentional and thus exempt as per the applicable definitions and guidance documents for Regulation EC 1907/2006.

Lenz declares that our products are exempt from registration or pre-registration obligations required in regulation EC 1907/2006. Preparations or Articles with Intended Releases produced or supplied by Lenz are specifically excluded from this Declaration statement. Since condition of use are outside Lenz control, Lenz makes no warranties, express or implied, and assumes no liability related to any use of this information.

Suppliers of articles must provide recipients with information on Substances of Very High Concern (SVHC) if those are present above a concentration limit of 0.1% on an article level. Lenz products do not contain any of the currently listed SVHC's. Lenz will continue to work with our suppliers to ensure that all SVHC's are notified to the European Chemicals Agency, if necessary, to comply with the REACH requirement.
